Welcome Tracy Stakely, New Superintendent - Congaree National Park



Tracy Stakely assumed the Congaree National Park's top administrator on January 14, 2013, replacing Tracy Swartout, who left for a position at Mount Rainier National Park. Stakely was formerly the chief of cultural landscapes in the Atlanta regional office of the National Park Service. He also served short-term assignments at Kennesaw Mountain National Battlefield and Mammoth Cave National Park. His focus in his 14 years with the National Park Service has been on documenting history of parks and facilities. SERCO welcomes Superintendent Stakely and looks forward to a continued partnership for preservation and the promotion of the Lower Richland area.
